HOW TO USE THE ENTRY FORM

Please note that Rally and Obedience are separate trials.

Use one entry form per dog if information is exactly the SAME for each day. Carefully check the block(s) for each trial in which you wish to enter your dog. You MUST use a SEPARATE entry form if you are entering your dog in a different class on different days.

TRANSFERS (Move-Ups) in Rally and Obedience Classes

Saturday Rally Transfers (after closing):

Transfers must be in writing and may be submitted for Saturday trials no later than 6 pm on Friday July 14, 2023. Transfers may be submitted via e-mail to bevmc8@verizon.net.

Saturday Rally Transfers (on day of trial):

- Transfers may also be submitted on the day of the trials as long as they are submitted at least 30 minutes before the start of the trial.
- Transfers following Trial 1 should be submitted to the Trial Secretary as soon as possible after conclusion of the class; transfers must be received before the start of the Trial 2 class.

Sunday Obedience Transfers: Transfers must be received in writing and may be submitted to the Trial Secretary for the Sunday trial no later than 6 pm on Friday, July 14, 2023.

- Transfers may also be submitted on the day of the trial as long as they are submitted at least 30 minutes before the start of the trial.
- Transfers following Trial 1 should be submitted to the Trial Secretary as soon as possible after conclusion of the class; transfers must be received before the start of the Trial 2 class.

WAIT LIST

- A WAIT LIST will be maintained (if needed) to fill openings created by entries that are withdrawn prior to the event closing date (Chap 1, Sec. 27)

PREFERENCE TO DOBERMAN ENTRIES

- Doberman entries will be given preference in entry acceptance per AKC Rally Regulations, Chapter 1, Section 1, Option (2). This means Doberman Pinscher entries will be given preference and automatically entered into these trials for the first 15 days after opening date. Non-Dobermans entries will be accepted to the wait list until after the Doberman preference period has expired on June 15, 2023. On June 15, 2023 all wait-listed non-doberman entries will accepted into the trial(s) in date order received. After June 15, entries will be accepted from AKC registered Dobermans and non-dobermans until the maximum is reached (not to exceed 8 hours judging time for both trials on that date).

Entries without fees will not be accepted. Acknowledgement of entries will be made as soon as practical. Should such acknowledgement not be received by the exhibitor within 5 days, please notify the Beverly McGhghy, Trial Secretary at 757-773-4282 or bevmc8@verizon.net.

Entries not on official AKC entry forms or photocopies of entry forms without the agreement and rules on the reverse side of the official AKC entry form are not acceptable. Returned checks do not constitute a valid entry. A \$25.00 service fee will be added for all returned checks.

Express entries: Please use "release signature" or the entry will be delayed.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Females In Season: All but \$3.00 of the entry fee may be refunded for bitches who come in season after the closing date by supplying the Trial Secretary with a certificate from your veterinarian dated on or before the day of the trial.

Entry fees shall not be refunded if a dog is absent, disqualified, excused by Veterinarian or Judge at the trial site, or barred from competition by action of the Trial Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event, it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

Consult judging program for time of judging.

Dogs may arrive at any time prior to their scheduled time of judging. Dogs not required for further judging will be excused. **All dogs present** must be held on leash or confined to their crates except when being judged.

Judges will not wait for any dog holding up a class. Owners or agents are responsible for the presence of their dogs in judging ring when their classes are called to be judged.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

INSTRUCTIONS

1. (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to AKC. (For complete rule refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
